A rare opportunity to acquire 0.46 acres (0.186 hectares) of land with agricultural outbuilding on the edge of Lustleigh within the Dartmoor National Park. The site benefits from direct highway access, level cleared areas, and substantial existing structures including a former piggery/storage building and four-bay pole barn with concrete hard standing. Fully enclosed and fenced, offering potential for a variety of uses subject to necessary consents. Freehold.



THE LAND AND OUTBUILDINGS

Access to the land is gained directly from the highway via a five-bar gate, leading to a sloping track that descends to more level, cleared area below. A public footpath runs along the right-hand boundary but does not cross the land itself. In all the land extends to 0.46 acres (0.186 hectares) and is held on two Title Deeds being DN754505 and DN68994.

The site benefits from an existing structure, including a substantial outbuilding previously used as a piggery and for storage. This building features concrete block work construction with windows to the front elevation under a corrugated roof, and is internally divided, measuring approximately 58'6" x 15'5" (17.83m x 4.7m). Adjoining this is an open-fronted four-bay lean-to pole barn with concrete hard standing, measuring approximately 39'5" x 9'3" (12.01m x 2.82m).

This plot is private and secluded and includes both woodland and a level area of land immediately around the outbuildings. The land is fully enclosed and fenced to all boundaries, with the terrain sloping more steeply down the right-hand side.

Situated within the Dartmoor National Park, this land offers potential for a variety of uses, subject to obtaining any necessary consents and planning permissions.

TENURE

The land is being offered for sale freehold with vacant possession on completion and is outlined in blue on the attached plan. Please note the plan is for identification purposes only and not to scale.

OVERAGE/CLAWBACK CLAUSE

A clawback clause will apply to the land. This means that if the land is developed in the future, a percentage of the uplift in value will be payable to the current sellers. Full details of this clause, including the exact terms are available upon request.
