# 7 Homebell House, Aldridge

An internal inspection is essential for the discerning purchaser to begin to appreciate this well presented one bedroom ground floor Retirement Apartment that benefits from direct access to the communal gardens and car park. The property is situated in a sought after development in the heart of Aldridge Village Centre with local amenities close at hand.

Aldridge has the benefit of all main shopping facilities including a Morrison superstore in the centre of the village whilst recreational facilities are provided at The Stick and Wicket Club at the Green with cricket, running, football and hockey whilst Aldridge Sailing Club can be found at the junction of Stubbers Green Lane and Barns Lane. The splendid Druids Heath Golf Club is located off Stonnall Road.

Regular public transport services run to many local areas, whilst junction 7 of the M6 motorway at Great Barr is within approximately 5 miles, which gives further access to the M5 and M42 whilst the M6 Toll Road is accessible at Brownhills (5 miles) thus giving easy access to all main centres, Birmingham Airport, International Rail Station and The National Exhibition Centre.

The accommodation that enjoys the benefit of electric heating and PVCu double glazing, briefly comprises the following:

entrance door, ceiling coving, security intercom to main entrance, ceiling light point and storage/airing cupboard off housing the water tank.

range of modern fitted white high gloss wall, base units and drawers, working surfaces with tiled surround and inset single drainer sink having mixer tap over, built in electric oven and hob with extractor canopy over, space for fridge/freezer and wall light point.

3.68m x 2.64m (12'1 x 8'8)

PVCu double glazed window overlooking the communal gardens, built in wardrobe, wall light point, ceiling coving and modern electric radiator.

## **MODERN SHOWER ROOM**

large walk-in shower enclosure with electric 'Mira' shower fitted, pedestal wash hand basin, wc, tiled walls and floor, wall light point, heated towel rail and extractor fan.
