Location

North Building is a contemporary building located on the banks of the River Avon situated within the high specification and desirable development of River View Court. The World Heritage City of Bath offers fine dining, boutique shops, The Theatre Royal and the architecturally unique Thermae Spa. There are transport links to London either from junction 18 of the M4 which lies to the north of the city or by rail from Bath Spa railway station to London Paddington (Approx. 90 mins), which is a flat walk from the apartment. There is also a cycle path which forms part of the Kennet and Avon cycle route providing a great route to Bristol.

Internal Description

Once inside there is a communal entrance hall with both lift, and stair access up to the apartment. On entering the apartment there is a light hallway with a good size storage cupboard which houses the boiler. The apartment boasts a fantastic open plan living/dining space and kitchen. This is a well balanced room with windows offering southerly views. The room offers ample space for both a dining area and sitting area. The kitchen is modern with white handless wall and base units, that includes built in single oven, hob and microwave. There is also a built in fridge freezer, dishwasher, washing machine and inset sink unit with mixer tap.

The bedroom is a good size double and benefits from a built in wardrobe and a large window to the rear. The accommodation is completed by the fully fitted bathroom suite. This comprises of a bath with hand held shower and rain shower over, wash hand basin, w.c and towel radiator.




