Comprehensively modernised by the current owner to include rewire, replumb, replacement kitchen, shower room, carpets and decoration throughout, the chain free accommodation briefly comprises: Private Hall with built in Cloaks Cupboard and Store, front Living Room with sliding doors to Patio and open plan to Dining Area, fitted Kitchen/Breakfast Room, three Bedrooms, Shower Room and Separate WC.

The development stands in established gardens with parking to the front and rear. A garage forming part of a block to the rear is included within the sale.


