Sitting Room – Dado rail, stripped wood flooring, cast iron fireplace with tiled hearth, built-in cupboard, radiator.

Kitchen/Breakfast room – Range of matching base units and wall cabinets, granite worktop, ceramic sink, five ring range style oven, extractor hood over, spotlights, wood laminate flooring, under stairs storage cupboard, exposed timber beams, open to the office space, radiator.



Office space – Double doors to rear garden, Velux window, brick-built fireplace with wooden mantel and decorative multi-fuel burner, terracotta tiled floor.

Utility space - Storage cupboard with washing machine, housing gas boiler, spotlights, stone flooring.
