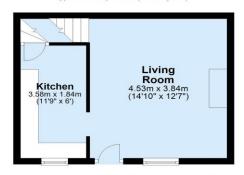

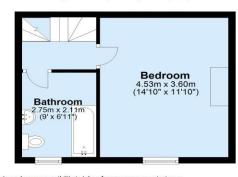
# **Ground Floor**

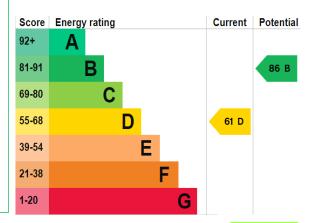
