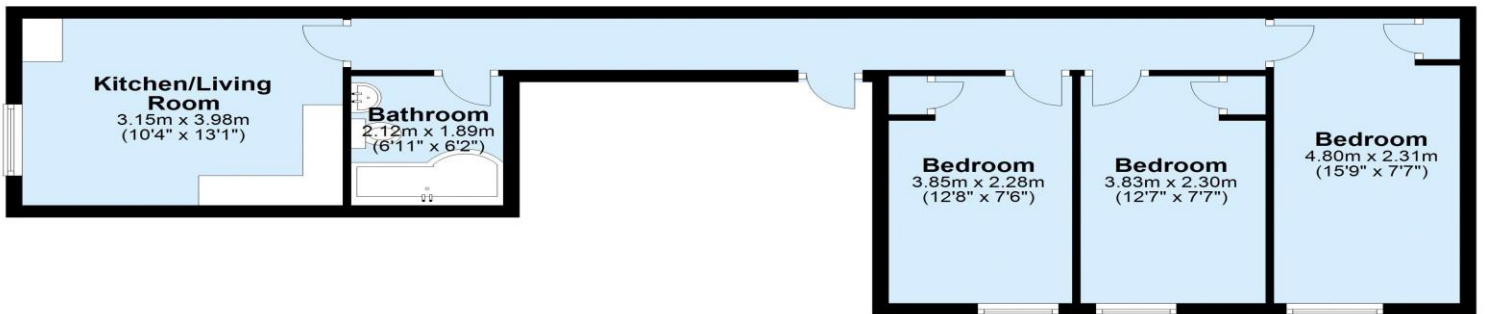

Tenant application process
