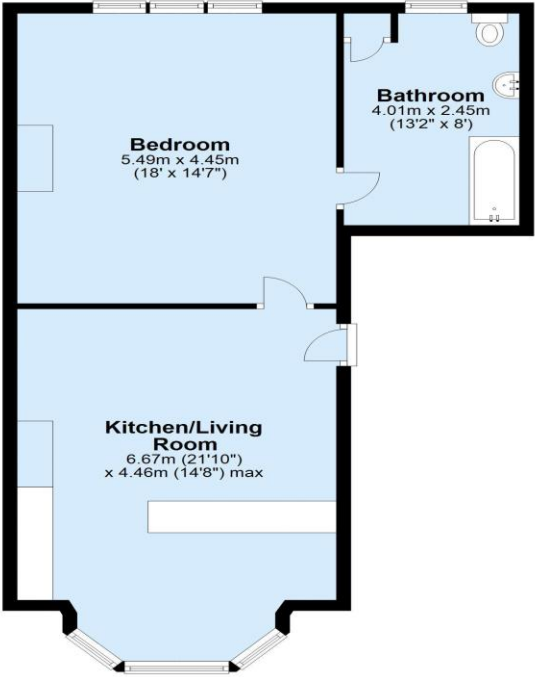

**Tenant application process**

In some cases a guarantor may be required. All rents are due at least one month in advance.
