An obscure glazed door opens to the Entrance Porch, with obscure glazed windows and an obscure double glazed door to:

#### Living Room 12'0 x 12'0 (3.66m x 3.66m)

Having a double glazed window to the front, an electric feature fire, television point and a door to:

## Dining Room 12'0 x 8'10 (3.66m x 2.69m)

Having a double glazed door to the garden, laminate floor, telephone point, stairs to first floor with useful storage cupboard below and an opening to:

## Kitchen 7'3 x 6'10 (2.21m x 2.08m)

Having double glazed windows to the side. The kitchen is fitted with a selection of wall and base unite with work surfaces over and tiled returns. There is a one and a half bowl sink unit, electric oven with electric hob, space for a dishwasher and opening to:

## Utility Room 7'2 x 5'1 (2.18m x 1.55m)

Having an obscure double glazed window to the side, a selection of wall and base units with work surfaces over and spaces for a fridge freezer, washing machine and tumble dryer. A door opens to:

#### **Ground Floor Bathroom 9'7 x 6'4 (2.92m x 1.93m)**

Having obscure double glazed windows to the side and rear, spotlights, extractor fan, wall mounted electric heater and a white suite comprising of a low level WC, his and hers vanity wash hand basins, a corner spa bath and a separate shower cubicle.

#### **First Floor Landing**

Having doors to Bedroom One and Two and a door to stairs to the second floor bedroom.

## Bedroom One 12'0 x 8'1 min (3.66m x 2.46m min)

Having a double glazed window to the front and built in wardrobes either side of the chimney breast.

#### Bedroom Two 9'8 x 9'2 (2.95m x 2.79m)

Having a double glazed window to the rear and airing cupboard over the stairs.

# Bedroom Three 21'4 x 10'10 min (6.50m x 3.30m min)

Having double glazed windows to the front and rear, skylight to the rear, laminate floor, built in wardrobes to either side of the chimney breast and a dressing table.

#### **Outside**

The front garden is laid to paving with a wrought iron gate and dwarf wall. The rear garden has a pleasing southerly aspect with a paved seating area with a palm tree that provides some welcome shade. An area of lawn leads to a gate that opens to an area of off road parking for one vehicle. Further parking is available in the road and is subject to a parking permit which the property has the option to apply for up to one resident permit and two visitors permits that are available from Wychavon at £40 a year per permit.

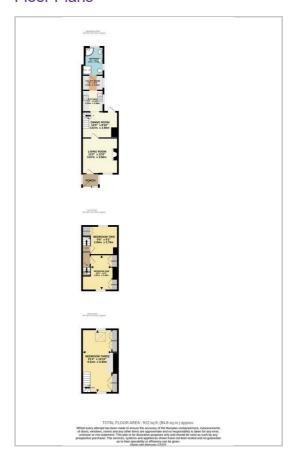

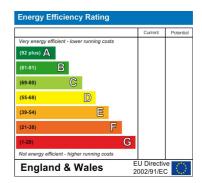
## Area Map
