



- Open plan kitchen/family room with tiled flooring, windows to 2 elevations and glazed doors to rear sun terrace and garden.
- The kitchen area benefits from an extensive range of units with granite working surfaces and appliances.
- There is also a cloakroom on the ground floor and access to large useful cellar rooms.
- Staircase from hall to first floor landing where there are 4 bedrooms and a large family bathroom with separate shower.
- There is a secondary enclosed staircase which leads to the second-floor loft room which would make a good play area or home office.
- Gas fired central heating and partial double glazing.
- Wrought iron gated access to a substantial driveway with an adjoining walled front garden.
- Magnificent private rear garden which is of a good size and beautifully landscaped to lawn with established beds and borders and a large, raised terrace. There are also 2 useful brick-built stores which adjoin the rear of the property as well as a greenhouse.
- The current owners have informed us that the property has previously had planning permission approved for an extension/annex.
- Very convenient location within walking distance of the fantastic and varied amenities of Coleham, along with both the primary school and both Meole and Priory secondary schools.
