

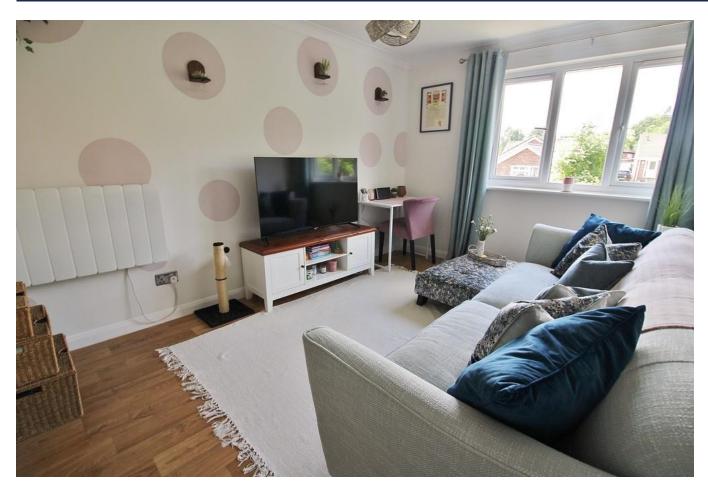

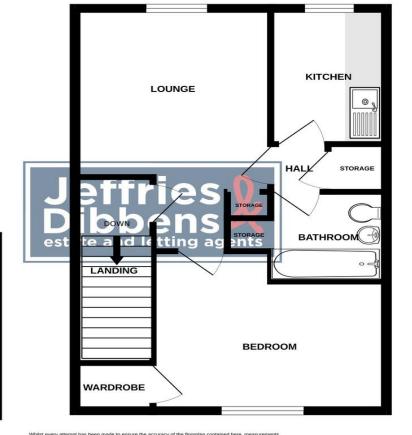
BATHROOM Panelled bath with shower over, hand wash basin, W.C, door to storage cupboard.

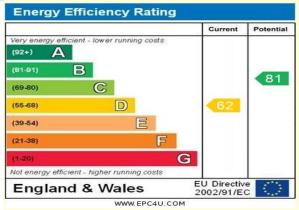
