

in both the state and private sectors.




### **Description**



At the rear is a spacious kitchen/breakfast family room with sliding glass doors that lead out to a covered & heated loggia. Upstairs on the first floor is a large principal bedroom suite with a walk-in dressing room and en suite bathroom with a separate shower. There are three further double bedrooms all with built-in cupboards and en suite shower rooms.
