Situated in small development in the heart of this sought after village of Kennington, conveniently located for both Oxford and Abingdon and within close proximity to many local amenities.

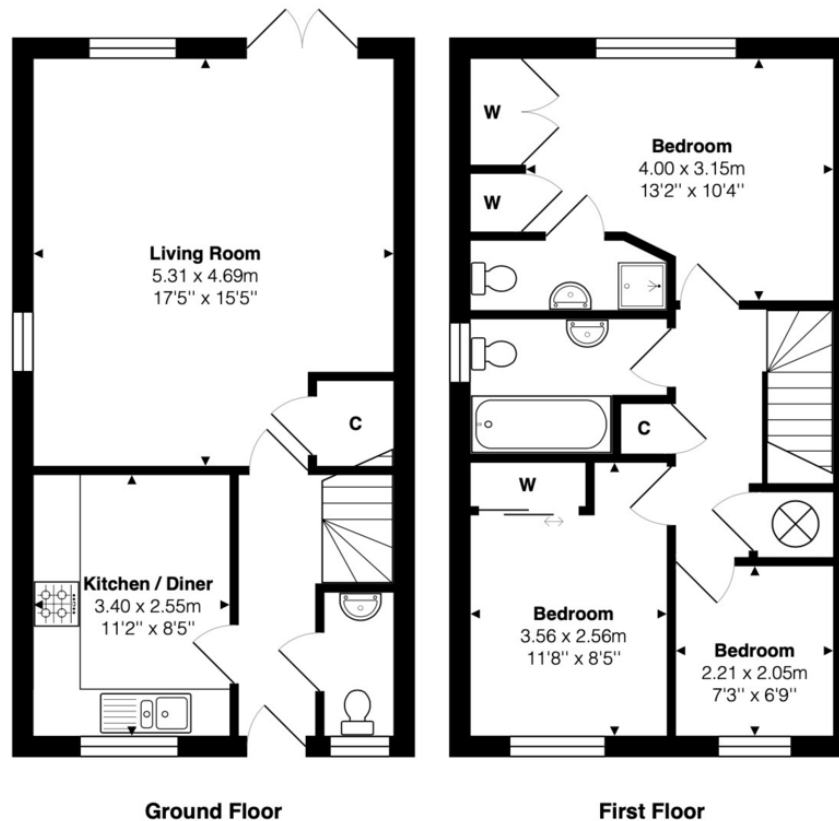
