THE DWELLING

Birches is a substantial modern bungalow of rendered block construction under a tiled roof, built in the 1970's, with well kept gardens surrounding the property. Situated in quiet and secluded, yet central, position in the village, with a lovely aspect towards the surrounding rural countryside.

ACCOMMODATION

Recently renovated throughout, the accommodation is spacious with beautifully appointed fitted kitchen and bathrooms. The dual aspect kitchen / dining room is a considerable size with 'island' and space for a large dining table, a sliding patio door leads to the side garden. Appliances include a range cooker with extractor fan over, integrated dishwasher and drinks fridge; there is space for an American style fridge / freezer. Additionally there is a utility room as well as a cloakroom with WC. The sitting room has a wood burning stove and a set of French doors to the South facing gardens. All four bedrooms are a good size and there is a contemporary family bathroom. The master bedroom has French doors to the garden, a contemporary en suite shower room and walk in dressing room.

OUTSIDE

Birches is accessible via a private driveway leading the parking area for multiple cars with a detached single garage with oil fired boiler and electric up and over door. The gardens are a good size and surround the property. The bulk of the garden is South facing and is mainly laid to lawn with areas of flower borders and a vegetable area in the corner. Surrounded by trees and shrubs the garden has a secluded leafy feel and is securely gated to to the front.

SITUATION

Birches is situated toward the centre of this unspoilt village which lies in a sheltered chalk valley, surrounded by some beautiful countryside. The village itself has an active community with a village hall, parish church, and the renowned Greyhound public house. Cerne Abbas is about 2 miles with a first school, doctors' surgery and dispensary, village store, and three public houses. Dorchester, Sherborne and Yeovil all have mainline railway connections to London/Waterloo.


Church Lane, Sydling St. Nicholas, Dorchester
