THE PROPERTY

Situated on Chydyok Road in the sought-after village of Chaldon Herring, this beautifully positioned cottage offers spacious accommodation and enjoys a wonderful garden that opens directly onto neighbouring fields.

The ground floor provides an excellent balance of living space. The sitting room spans the full depth of the property and is filled with natural light with a set of double doors opening out to the rear garden. The adjoining dining room offers plenty of space for family meals or entertaining, with direct access into the modern shaker style kitchen, which is smartly arranged with ample worktop space.

Upstairs, the property has three well-proportioned bedrooms. The principal bedroom is a generous double, while bedrooms two and three provide ideal options for children, guests, or a dedicated home office. A well-appointed bathroom and a separate WC complete the first floor.

OUTSIDE

One of the real highlights of this home are the front and rear gardens. With a lovely open aspect and uninterrupted views over adjoining fields, it feels wonderfully private and peaceful. It's a true extension of the living space and a standout feature of the property.

SITUATION

Chaldon Herring or East Chaldon is a picture eque village nestled in a valley, about two miles from the coast. Within the village there is a church and public house (The Sailor's Return).

The nearby village of Winfrith Newburgh has a general store/post office, public house and first school. There are more comprehensive facilities in Wool and Dorchester, both with mainline railway stations on the London Waterloo line. Lulworth Castle is about five miles with the stunning Jurassic Coastline offering scenic walks and access to beaches. There is some spectacular walking and riding in the surrounding countryside and along the Dorset coast, designated a World Heritage site.
