

## THE PROPERTY

Situated in the prestigious Barley Building on Brewery Square two double bedroom apartment, designed by Conran & Partners, benefits from a high quality fully fitted kitchen designed by Paula Rosa with a range of modern integrated appliances including fridge, freezer, dishwasher, microwave, oven and electric hob. The open plan living space has upgraded noise reducing glass sliding doors leading out to a small sunny balcony which has open views beyond the town and lets in a wealth of natural light.

There is zoned underfloor gas fired heating with walnut veneered flooring throughout the kitchen/dining and living areas and carpet in the two bedrooms. The bedrooms have attractive built in wardrobes finished in walnut veneer. The contemporary family bathroom is fitted with handy storage and has a bath tub and the ensuite has a walk in shower with full travertine tiling complementing the quality bathroom fittings.

## OUTSIDE

Lift or stairs take you to the secure car park with an allocated parking space.

A spacious private paved terrace sits along side both bedrooms and has views over the communal gardens and space for outside dining, a rare find in Brewery Square living. An additional slim balcony to the front with elevated views. The additional tranquil communal Brewery Square Gardens for the enjoyment of Brewery Square residents can be enjoyed.

## SITUATION

Brewery Square boasts a development with a variety of eateries, including, Wagamama, Zizzi, Pizza Express, Vivo Lounge, Nandos, Brewhouse & Kitchen and Costa. The square also includes a Premier Inn, an Odeon Cinema and multiple fashion retailers. The Dorset County Hospital is nearby.

Dorchester south and west train stations provide services to London Waterloo and Bristol Temple Meads respectively. The main County town also provides a good range of shops, restaurants and leisure facilities. There are numerous sports clubs around the town including cricket, rugby, football, tennis and golf. There are many footpaths and bridleways across the beautiful surrounding countryside.






## Copper Street, Dorchester
