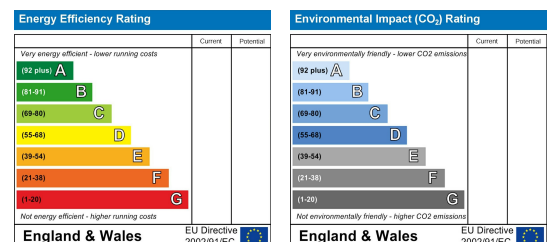
## Area Map
