## Location

Located off Annandale Road and Preston Road close to the Sports Stadium the property is within a short driving distance of the Holderness Road shopping area with its variety of local amenities including public transport, local schooling, a park with boating area and play facilities.

## Entrance Hall

Main front entrance door provides access into the property. Stairs lead off to the first floor accommodation radiator and access into:

## Lounge

11'7" to back of cb x 14'10" (3.552m to back of cb x 4.540m)

Window to the front elevation and radiator. Under stairs meter/storage cupboard. Door leading into the kitchen/diner.



## Kitchen/Diner

15'0" x 8'1" (4.582m x 2.483m)

Fitted with a range of base and wall units, work surfaces with single drainer sink unit. Space for appliances. Wall mounted gas fired central heating boiler, radiator and window to the rear elevation with rear entrance door.

## First Floor Landing

Loft hatch. Doors leading into three bedrooms and bathroom.



## Bedroom One

9'9" max x 14'3" max (2.986m max x 4.347m max)

Window to the front elevation, radiator and cupboard.

## Bedroom Two

8'10" x 8'11" (2.693m x 2.720m)

Window to the rear elevation and radiator.

## Bedroom Three

6'11" x 9'11" includes bulkhead (2.115m x 3.037m includes bulkhead)

Window to the front elevation, radiator and bulkhead.

## Bathroom

7'10" x 5'5" (2.404m x 1.666m)

Three piece suite of bath with shower attachment to the taps, wash hand basin and WC. Window to the rear elevation, tiling to the walls and towel rail radiator.



## Outside

Garden areas to the front and rear. Shared passage leading to the rear garden. Outhouse to the rear.


