#### **INTERNAL**

The property is entered from front aspect via glazed entrance porch into an entrance vestibule with staircase rising to first floor and providing access to a useful ground floor shower room comprising shower cubicle, basin and WC.

There is a spacious sitting room with marble effect fireplace housing real flame effect gas fire and full height cupboards to one alcove. The dining kitchen has fitted units with sink, Aga inset into chimney breast with cupboards either side, and space for fridge. There is access to cellar from the kitchen and a there is a further glazed porch to the rear of kitchen with plumbing for washer and door to garden. A three-piece shower room completes the ground floor accommodation.

To the first floor the landing area has a window affording superb views. There are two double bedrooms, both with built in storage, with a third bedroom having a fitted wardrobe and staircase to attic room, an ideal dressing room or study. There is a four-piece bathroom comprising bath, corner shower, WC and basin.

The second-floor attic room would make a good sized bedroom with some limited headroom and window to gable end.

#### **EXTERNAL**

The property benefits from a level lawn garden extending along the side of the property and to the rear, with mature shrubs and enjoying superb far-reaching views. There is parking in front of property on a shared drive.

#### LOCATION

The cottage is located within a short stroll of a popular country pub and a short drive from the centre of Barkisland and Greetland villages, which boast local amenities including village schools, churches, cricket club and post office/general store.

There is a regular bus service and the M62 motorway (J22 and J24) is within 15 minutes' drive allowing speedy access to the motorway network. There is a mainline railway station at nearby Sowerby Bridge.


#### DIRECTIONS
