LOCATION

Blakeney has become one of the most sought after coastal villages in North Norfolk.

The whole coastal area, much of it owned by the National Trust, is designated as an area of outstanding natural beauty attracting both sailing enthusiasts and ornithologists.

The village retains a unique atmosphere with many of the old mariners and merchants' houses remaining in narrow streets with other cottages tucked away in flint walled alleyways or lokes.

The High Street runs down to the quay with its saltmarshes and channels to Blakeney Point and beyond. There is a wide selection of shops, public houses and hotels.

A wider range of amenities can be found in the Georgian Town of Holt, about 5 miles to the south. Private education is provided in the town of Holt at Greshams School and further afield at Beeston Hall near Sheringham. Norwich, the Cathedral City and regional centre, provides a comprehensive selection of shopping, cultural pursuits, a mainline rail service to London Liverpool Street (110 minutes) and an international airport.

DIRECTIONS

On entering Blakeney from the A149 Coast Road from Cley turn right into Back Lane. Continue almost to the end and a Brown & Co 'For Sale' board will be seen on the right hand side.






View of Blakeney Quay and Blakeney Point at low Tide - Not visible from plot.
