#### LOCATION

Little London is an attractive hamlet just ¼ mile from Corpusty and Saxthorpe. Local footpaths afford access through the riverside meadows that were designated an Environmentally Sensitive Area in the past. Corpusty, with a shop/post office, public house, primary school and village hall is amalgamated with Saxthorpe on the north side of the river where the fine parish church stands. The B1354 provides ready access towards Fakenham to the west and to Aylsham to the east with The Broads beyond. The popular north Norfolk coast is approximately 10 miles to the north.

#### DESCRIPTION

A detached, brick and flint house situated in a quiet residential location in the village of Little London. The accommodation briefly comprises; entrance hallway, kitchen with archway leading to dining room, living room and cloakroom on the ground floor together with three double bedrooms and a family bathroom on the first floor. The property is approached via a large, shingled driveway providing ample off road parking with the benefit of an attached garage. There is a good sized garden to the rear which is mainly laid to lawn. Offered with no onward chain.








## Little London, Corpusty, Norwich, NR11
