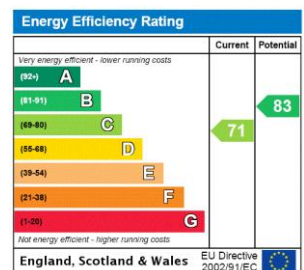

Vicarage Gate is set in this cul de sac, located in prime position moments from the amenities of Kensington High Street, Holland Park & Notting Hill Gate.

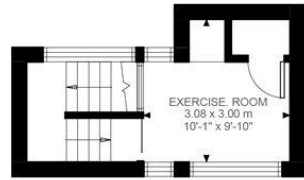

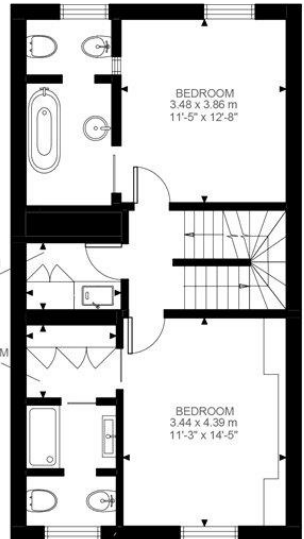

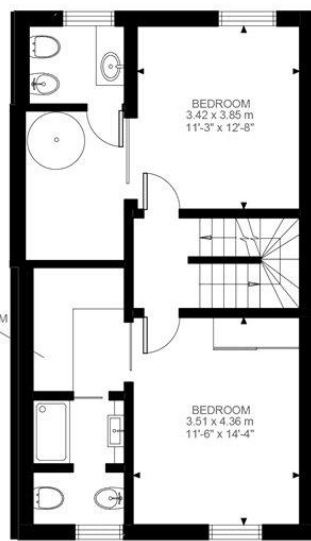
Third Floor
