Fairfax Court is a desirable residential development with South facing communal gardens and close to the River Weaver. There is a lovely riverside walk to Nantwich town centre. The stairs and lift lead from the communal entrance to No. 8, on the first floor. This is an ideal lock up and leave, first time or downsizing opportunity.

LOCATION & AMENITIES

Fairfax Court is located off Barony Road, close to Barony Park, convenient stores and the River Weaver. Nantwich town centre is .75 of a mile and offers a comprehensive range of services with high street retailers, banks, restaurants, leisure facilities and supermarkets. 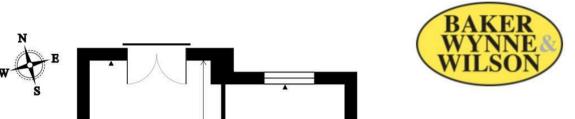

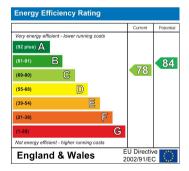
