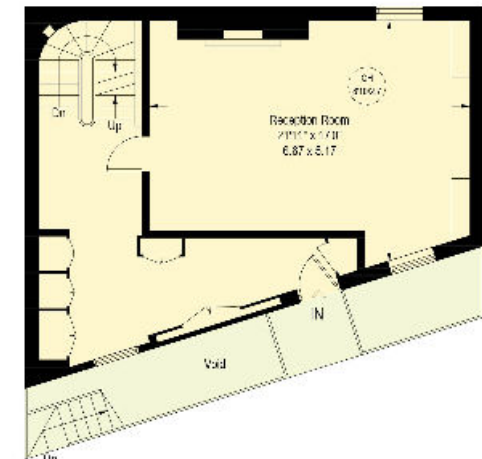
First Floor
