The accommodation is formed over one level comprising; lounge with open plan dining and kitchen, two bedrooms (master with en-suite bathroom) and shower room. The large bright lounge has a vaulted ceiling, feature fireplace, wall mounted TV, side table and comfortable luxury 3-piece suite with large patio doors to the decked

seating area with hot tub. The modern kitchen has built-in appliances (cooker, dishwasher, microwave oven, washing machine/dryer, wine chiller), freestanding American style fridge/freezer, island with concealed power point and floor and wall mounted units with complementary work surfaces. The master bedroom has an en-suite bathroom and walk-in wardrobe. The second bedroom is a twin with two single beds and benefits from a built-in wardrobe. The shower room suite consists of WC, wash hand basin with vanity unit below and shower cubicle.

The property benefits from LPG fired central heating and double-glazing throughout.

Stewarts Resort is open 12 months of the year and this property has a leasehold of 39 years (as of March 2024). The development is 5-Star luxury and has an excellent range of on-site facilities which include restaurant, sauna/steam room, gym, golf practice simulator and play park as well as a regular bus/student shuttle service to and from St Andrews.
