ACCOMMODATION

The entrance door opens directly into the living room.

Overlooking the front, the living room has a part glazed door opening to the dining room. The dining room has stairs rising to the first floor, a door opening to the rear garden, a feature wall, and access to the galley kitchen.

Fitted with a range of wall, drawer and base units with work surfaces over, the galley kitchen has a stainless steel sink and drainer unit with a mixer tap over, and space for a cooker. There is a window to the side.

On reaching the first floor, the landing gives access to two bedrooms (one with a range of built in wardrobes), and the family bathroom. The family bathroom is fitted with a bath with a shower attachment over, a wc, and a wash hand basin.

OUTSIDE

At the front of the property, the driveway provides off road parking for two vehicle, and gives access to the entrance door.

The south facing rear garden is fully enclosed and includes; a decked seating area, and a lawned area. The garden has an external light, an external tap, and also houses a storage shed.

(There is shared access across the gardens, allowing for bins to be moved).


