Newbury and Hungerford offer a wide range of shopping and recreational facilities, and both have stations providing access to Paddington within about 50 minutes.

The M4 and A34 are within easy access and provide access to London, Heathrow, Oxford, Southampton and the South Coast.

Many well-regarded state and independent schools in the area include a primary school in Stockcross, Cheam, Downe House, Horris Hill, Thorngrove, and Marlborough College.

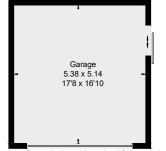






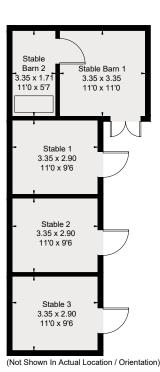

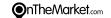
