Harts Meadow is believed to date from the 1970s, with later additions in the 1980s and 2010.

Planning permission was granted in September 2021 for a replacement four bedroom dwelling with a garage and outdoor pool (Application no. 21/02129/FULLN).

Planning was also granted in January 2021 for a two-storey side extension and remodelling of existing ground and first-floor accommodation, demolition of the existing garage and store, and erection of a new timber-clad double garage (Application no. 20/02822/FULLN).

It is tastefully presented with light accommodation and has been modernised and well maintained.

Garden and grounds

The property is approached via a pair of electric wooden gates which lead to a parking area.

There is a barn and garage with electric doors, water and electricity, together with four boxes, a tack room/hay store and a kitchen.

Beyond the stabling lie two well-drained paddocks, bordered by post and rail fencing with water.

There is excellent riding out with direct access to a byway.

Steps from the terrace lead down to a private rear garden, mainly laid to lawn.

There is a summer house, greenhouse and sheds.









Hampshire

Harts Meadow is a charming property in Vernham Street, a small rural hamlet north of Vernham Dean and Andover.

The property is located in the North Downs Area of Outstanding Natural Beauty.

Nearby, Vernham Dean has a village hall, public house and primary school. There is a part-time doctor and post office facility.

More comprehensive shopping facilities can be found in Andover, which has a Waitrose and a regular Farmers Market.

Communications are excellent, with trains from Andover to London Waterloo taking just over an hour and Hungerford to London Paddington taking about 60 minutes. The A303 is within easy access and provides fast access to the West Country and London.

There are many well-regarded state and fee-paying schools in the area, including the primary schools in Vernham Dean, Farleigh, Thorngrove, Godolphin, Winchester College and St Swithuns.

Andover 8 miles (London (Waterloo 65 minutes), A303 9 miles, Hungerford 8 miles (Paddington 60 minutes), Newbury 14 miles, Marlborough 15 miles, Winchester 25 miles and Salisbury 27 miles.
