





DESCRIPTION

The Starlings are in a three-house private gated development, just off Holtwood Road, which is close to Oxshott village and Oxshott train station.

On the ground floor and set around a spacious entrance hall are the drawing room, dining room, study, open-plan kitchen and vaulted family room with bi-fold doors opening onto a large rear patio. There's also a cloakroom and separate utility room. Upstairs, the principal bedroom includes built-in wardrobes and a large en suite. There are two further en suite doubles and two additional bedrooms served by a family bedroom.




