- Shipston on Stour is a popular former market town with an attractive Georgian centre situated in south Warwickshire.
- The town is a busy local centre with good shopping, schooling and recreational facilities serving its own population and a number of surrounding villages.
- There are grammar schools locally at Alcester and Stratford upon Avon.
- The larger centres of Stratford upon Avon, Banbury and Oxford are accessible. The area is serviced by a network of main roads including the A3400 (Oxford to Birmingham) road passing through the town.
- Junctions 11 and 15 of the M40 motorway are accessible at Banbury and Warwick respectively. There are mainline stations at Moreton in Marsh and Banbury with train services south to Oxford and London respectively.
- **1 West Street** is well located in the centre of Shipston on Stour close to the High Street on the corner of West Street (A3400) and Church Street (A3400) at the entrance of the one-way gyratory system.
- The retail sales area fronts onto West Street looking up Church Street in a prominent position.
- The Principal Retail Area extends to about 802 sq ft/74.5 sq m and has an overall depth of about 44'7"/13.59m off which is situated a show room and further retail area incorporating a changing/trying on area.

- To the back of the premises are separate Office and Storeroom off which is a Kitchen Area and Cloakroom.
- Storeroom extends to about 108 sq ft/10 sq m.
- **Kitchen Area** with fitted kitchen unit incorporating stainless steel sink unit leads to the **Cloakroom**.
- On the First Floor is a further Office/Workshop and Store area extending to about 357 sq ft/33.2 sq m
