This cleared site now offers excellent potential for a developer to bring forward a high-quality residential scheme in a well established area of Egremont.


The site is easily located just off Egremont Main Street, directly opposite the castle. The postcode CA22 2FP will take you there, and a For Sale board has now been erected.
