The town offers a wide range of shops including supermarkets, banks and building societies and a bus station with regular services to nearby villages and King's Lynn. The property is just a short walk from the town centre and the beach which has a promenade, funfair, bowls, pitch & putt and sealife sanctuary. Hunstanton is an ideal location for a holiday home or permanent residence. King's Lynn is approximately 15 miles from Hunstanton and has direct train routes through to Ely, Cambridge and London.
