Extended three bedroom semi detached style property, requiring major updating and refurbishment throughout. Also requiring remedying of structural defects present.

Sliding door to front.

4.35m x 3.8m at widest point. (14'3" x 12'5" at widest point.)

Window to front, Gas fire.

Window to rear. Range of kitchen units with stainless steel sink and drainer. Wall mounted boiler. Door to storage cupboard.

1.87m x 2.03m at widest point. (6'1" x 6'7" at widest point.)

Access to loft and overstairs cupboard.

### **Bedroom One**

3.33m x 3.93m at widest point (10'11" x 12'10" at widest point)

Window to front.

### **Bedroom Two**

3.33m x 2.02m (10'11" x 6'7")

Window to rear.

### **Bedroom Three**

1.9 x 2.87m (6'2" x 9'4" )

Window to front.



### **Bathroom**

1.85m x 2.04m (6'0" x 6'8")

Three piece suite comprising: paneled bath, low level WC and wash hand basin.

FRONT: Partially lawned garden to front with path to front door.

REAR: Laid to lawn (overgrown) and patio area. Garden shed

## **Structural Survey**

Two storey extension to rear has a vertical gap up to 5mm wide and there are gaps to the sides of the front porch. A structural appraisal is available to view. There have been leaks from the water tanks in the roof space.

## **Freehold**






