Tucked away in a no through road just off the popular Uplands area of the city, this extended two bedroom bungalow is well presented throughout and offered without any onward chain. Steps from a block paved hard standing area take you to the front door where you enter a generously sized vestibule. Double French doors open through to the kitchen/breakfast room which has a range of attractive cream coloured cabinets, ample worksurface including a breakfast bar, and an integrated gas hob, oven and extractor. The living room has patio doors to the sun terrace and garden. There are two good sized bedrooms and a bathroom with a white suite and shower over the bath. The garden is delightful and enclosed, with a lawned area and sun terrace. A single garage is located in the block near by. The property is warmed by gas central heating.
