#### Location & Description

Saltash is located on the western banks of the Tamar Estuary, opposite to the City of Plymouth, and is the eastern gateway to Cornwall on the A38, the principle road through the south of the county.

Saltash is the 6th largest town in Cornwall with a current population in excess of 16,000 and, as one would expect, contains a mixture of both national and local occupiers primarily based around the retail centre of Fore Street. The property is prominently located on Fore Street on a row of retailers that include Barclays Bank, Martin McColl's Newsagents, Saltash Sports and Fox & Sons Estate Agents opposite Lloyds TSB and the Co-operative convenience store.
