Pleasantly situated just a short distance from town amenities, including Stourbridge bus station, this RATHER INDIVIDUAL, TWO-BEDROOM, END OF TERRACE HOME should interest first-time buyers. The gas centrally heated and double-glazed layout is complemented at the rear by a long garden and offered 'for sale' with NO UPWARD CHAIN.

From within, the accommodation has neutral décor and is planned over two floors, to comprise: Sitting Room, Further Rear Snug Area/Dining Area, Cellar, Fitted Kitchen, and White Bathroom. Upon the first floor, there is a mezzanine-style Double Bedroom with French doors and a further interconnecting Double Bedroom.

The property has a deceptive yet attractive external style, and to the rear, an exceptionally long garden with a water feature and decking.

While some updating could be beneficial, the property is overall well-maintained and ready for first-time buyers to create their own home. The location, just before Redhill and close to the town, is thought to be ideal. The selling agents recommend viewing.





