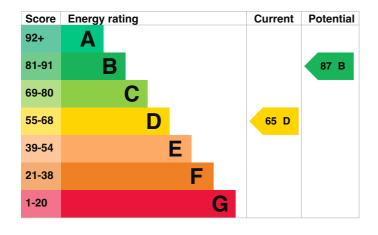
Properties can be let if they have an energy rating from A to E.

# How this affects your energy bills

8. Solar water heating	£4,000 - £6,000	£33
9. Solar photovoltaic panels	£5,000 - £8,000	£333
