Double glazed window to rear, central heating radiator and wardrobe

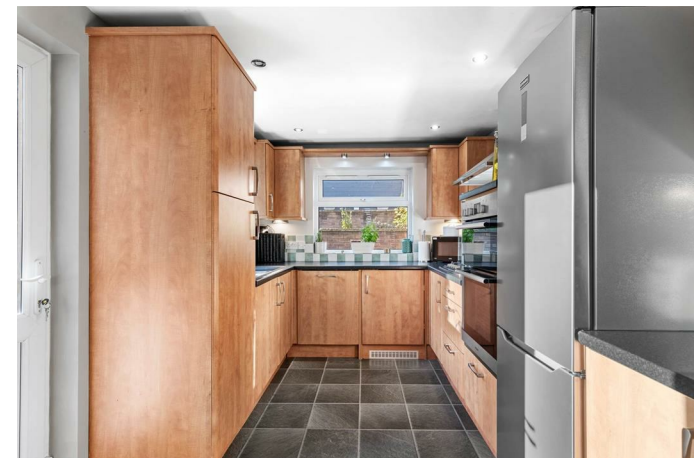

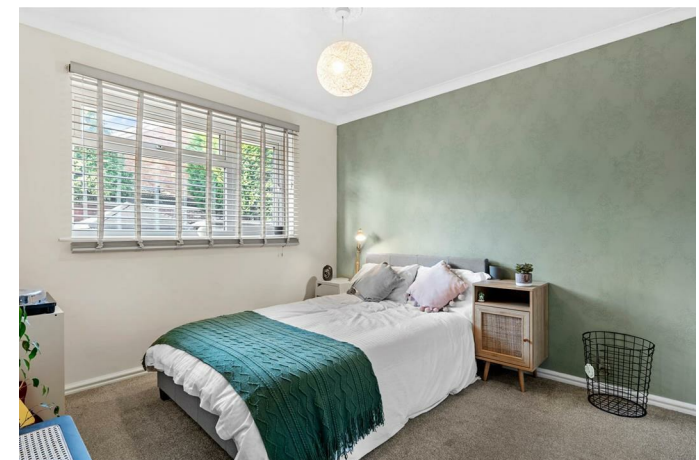
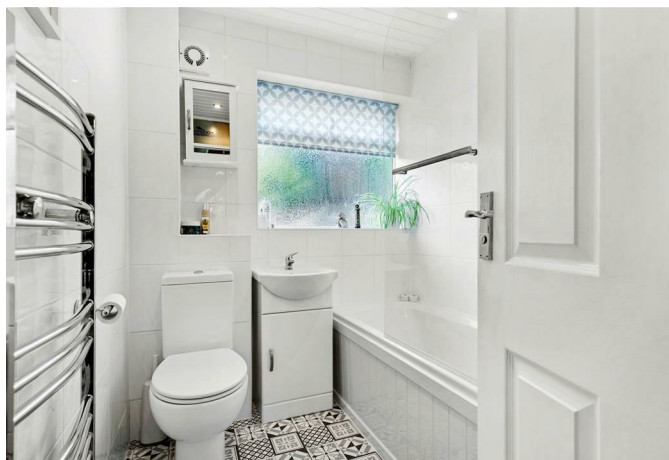
