Double glazed double doors to rear, double glazed window and door to front

Feature wash hand basin with mixer tap, low level w.c, tiled floor and splash backs, double glazed window to front and extractor fan

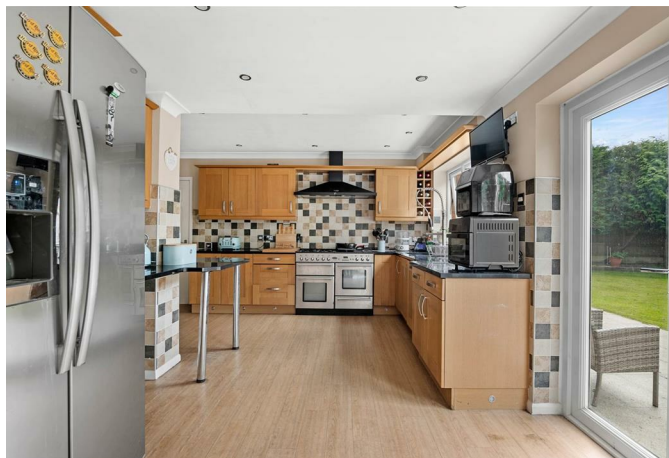
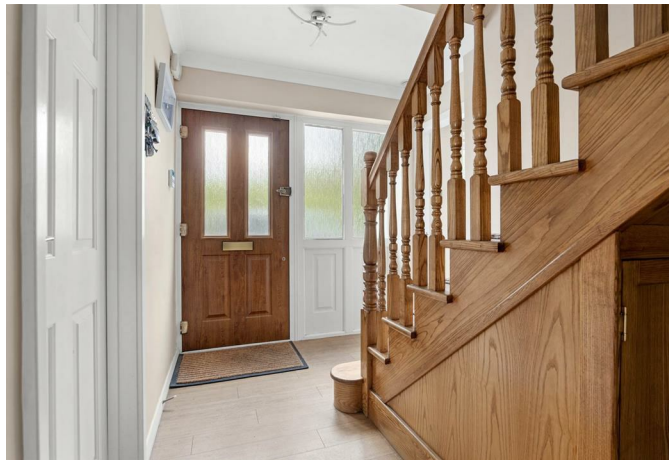
Window to side, main door to front and housing boiler

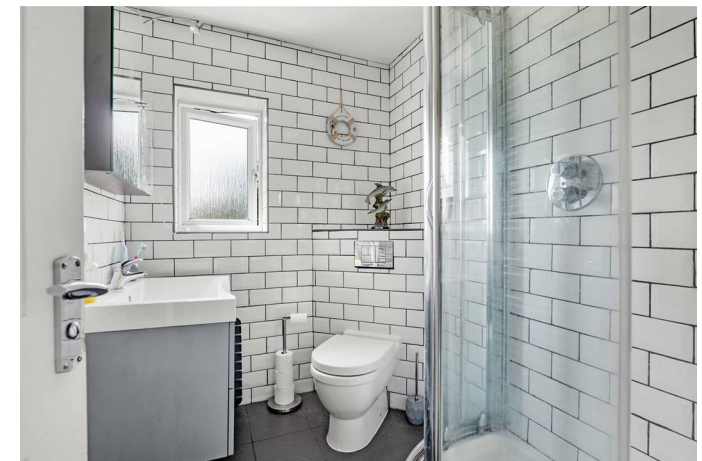

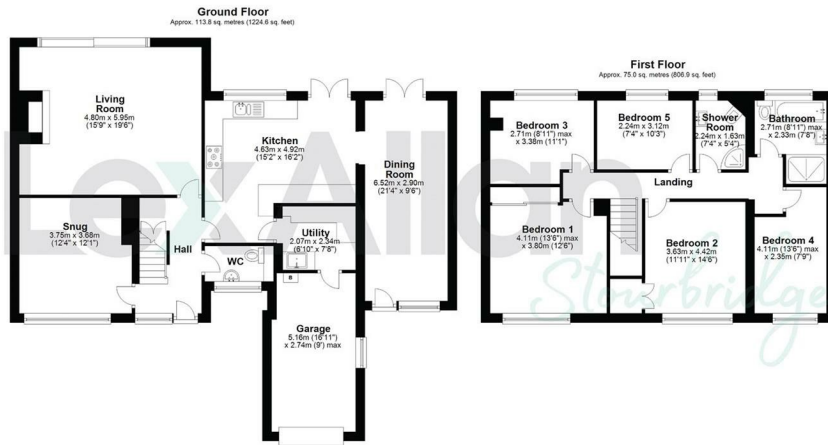
