Bay window to front, central heating radiator and feature fire

Double glazed window and door to rear and central heating radiator

Kitchen

Double glazed window to rear, range of wall and base units work surface over incorporating sink, gas hob with extractor hood over, oven, tiled floor and splash backs, space and plumbing for washing machine, door to side and cupboard housing boiler

Landing

Access to loft space and doors off

Bay window to front and central heating radiator

Bedroom Two

Window to rear and central heating radiator

Bedroom Three

Window to front and central heating radiator

Bedroom Four

Window to rear, central heating radiator and built in wardrobe



Bedroom Five

Window to front and central heating radiator

Wash hand basin with storage below, bath with electric shower over, shower, cupboard housing immersion tank, central heating radiator, tiled splash backs and window to rear

Metal double doors to front, window to side and door to rear

W,c, double glazed window to rear, wash hand basin, tiled floor and splash backs

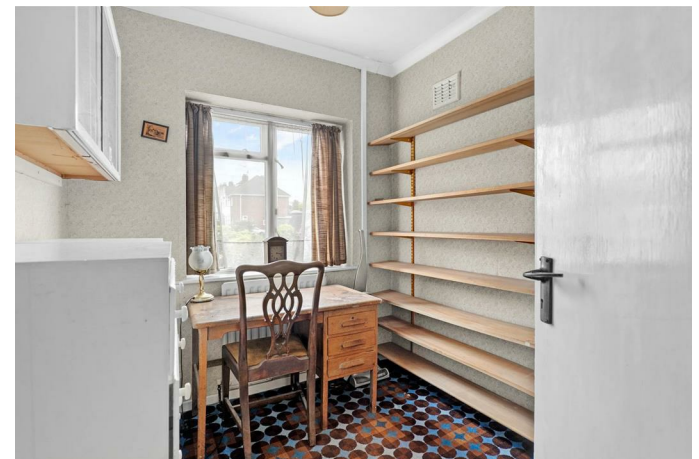

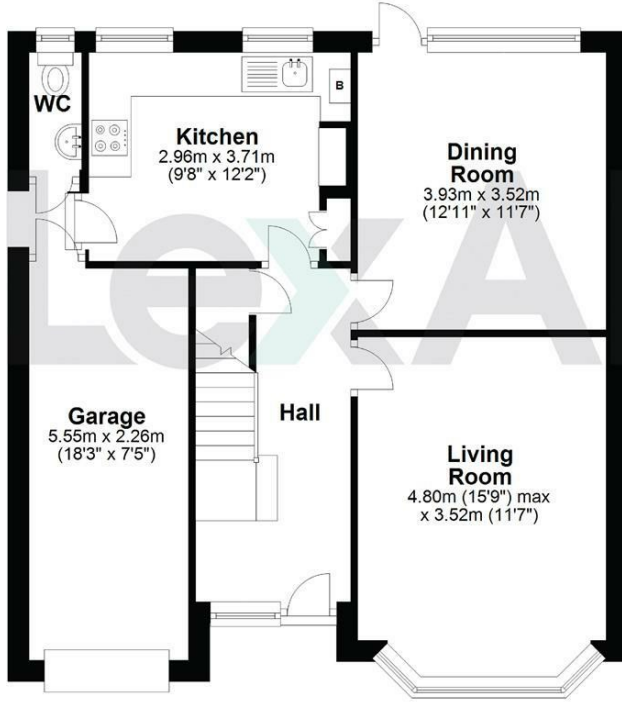
Council Tax Band F





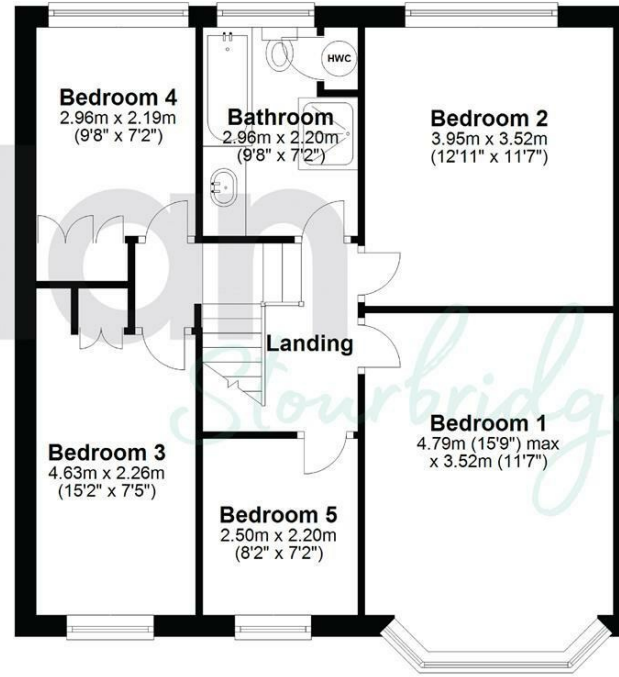
Ground Floor

Approx. 66.7 sq. metres (718.0 sq. feet)



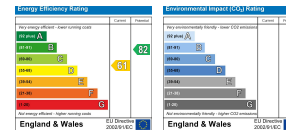
First Floor
