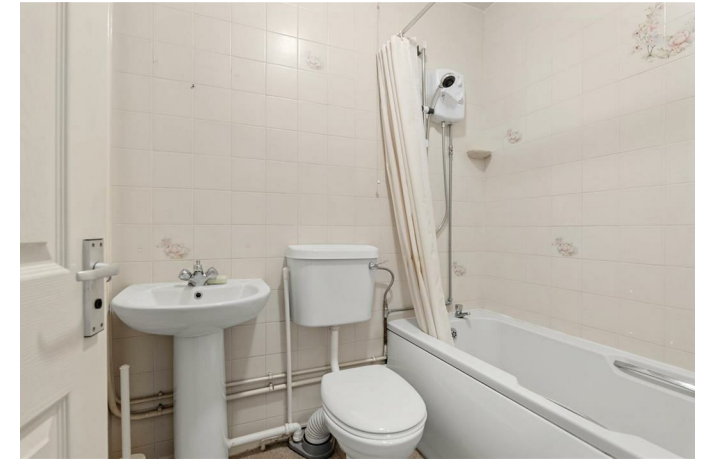

Tenure (Freehold).

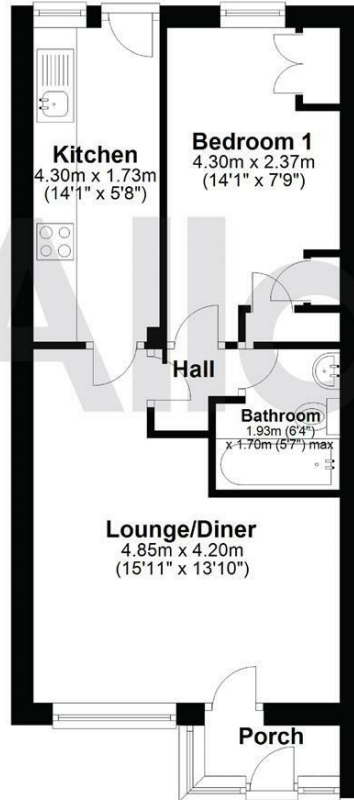

Council Tax Band A



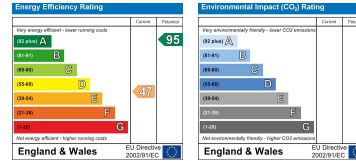


Ground Floor
