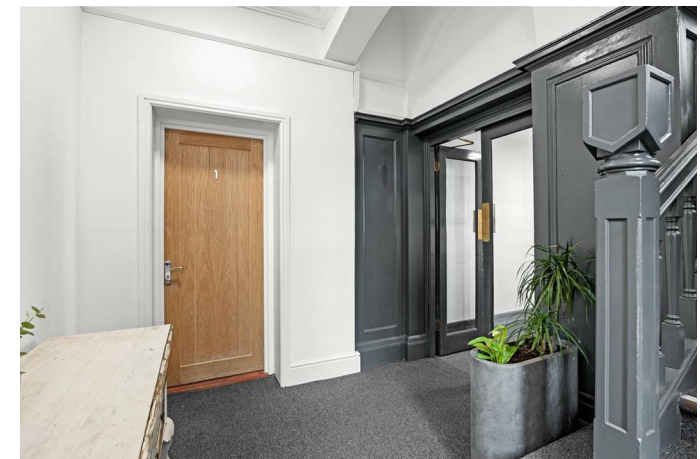
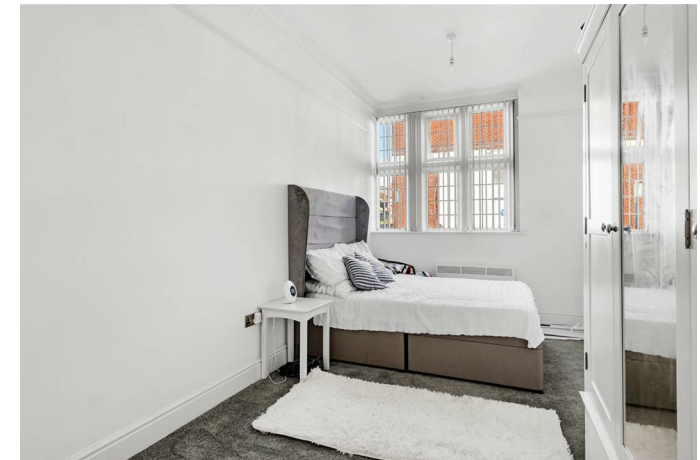

Tenure (Leasehold).

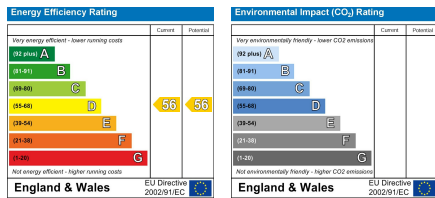
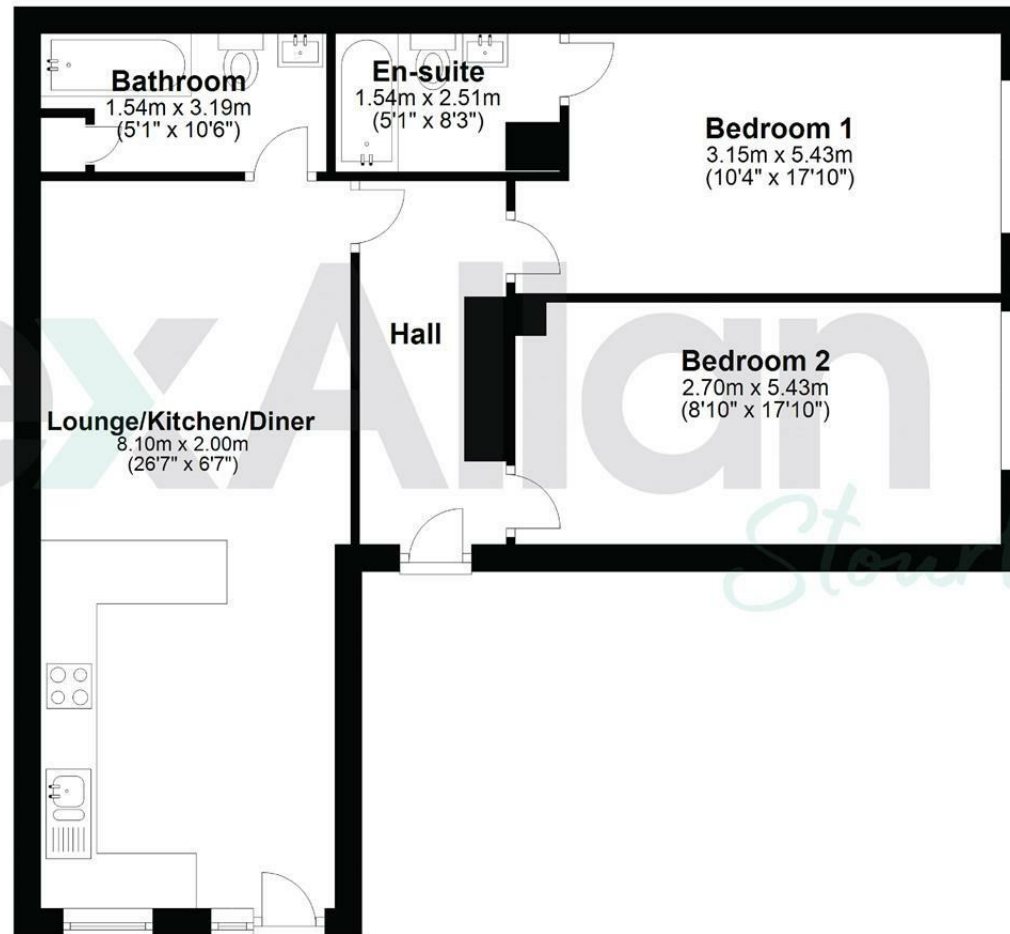
