Double glazed windows and door to rear, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated dishwasher, fridge and freezer, space and plumbing for washing machine, tiled floor and splash backs

Access to loft space, central heating radiator and doors off

Double glazed window to front and central heating radiator

Bedroom Two

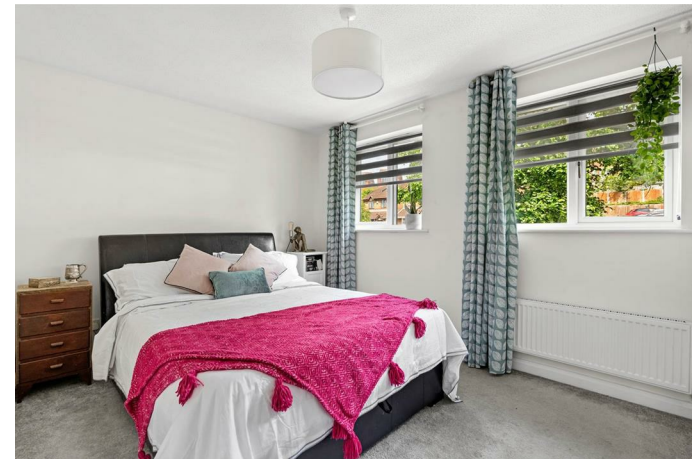
Double glazed window to rear with far reaching views, central heating radiator and cupboard off

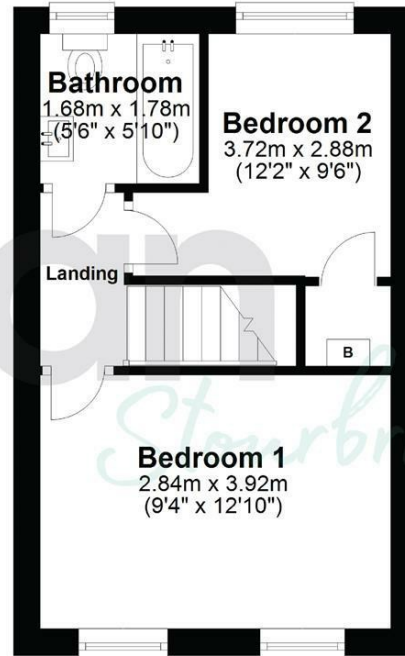
Ground Floor

Approx. 27.9 sq. metres (300.6 sq. feet)



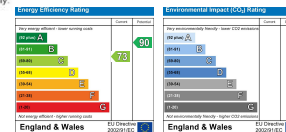
First Floor
