Approach

Tarmac driveway offering parking for a number of cars, gravel borders and side access

Entrance Porch

Double glazed window to front, stable door to side and tiled flooring

Lounge

Double glazed window to front, stairs off and central heating radiator

Kitchen

Door and window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, space and plumbing for washing machine, tiled floor and central heating radiator

Conservatory

Double glazed windows and doors, tiled floor and central heating radiator

Landing

Cupboard and doors off

Bedroom One

Double glazed window to front and central heating radiator

Dressing Room

Double glazed window to rear, central heating radiator and access to loft space

Bedroom Two

Window to rear, skylight, central heating radiator and access to under eave storage

Bathroom

Double glazed window to rear, central heating radiator, wash hand basin with mixer tap, low level w.c, bath with mixer tap and shower over and tiled splash backs

Rear Garden

Slab patio, side gate, summerhouse equipped with electrics and all with fencing to enclose


Tenure (Freehold).

References to the tenure of a property are based on information supplied by the seller. We are advised that the property is freehold. A buyer is advised to obtain verification from their solicitor.


Council Tax Band B




Ground Floor
