#### Entrance Hall

Double glazed door to front, central heating radiator and stairs off

#### Kitchen

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, integrated oven, dishwasher, space and plumbing for washing machine and extractor fan

#### Downstairs w,c

Low level w,c, wash hand basin with mixer tap and storage below, central heating radiator, tiled splash backs and extractor fan

#### Lounge

Double glazed window and door to rear, central heating radiator and cupboard off

#### Landing

Doors off, access to loft space and cupboard off

#### Bedroom One

Double glazed window to rear and central heating radiator

#### Bedroom Two

Double glazed window to front and central heating radiator

#### Bathroom

Bath with mixer tap and shower over, wash hand basin with mixer tap, low level w,c, tiled splash backs, heated towel rail and extractor fan

#### Garden

Slab patio, lawn, flower beds, side gate to further lawn area and shed, and all with fencing to enclose

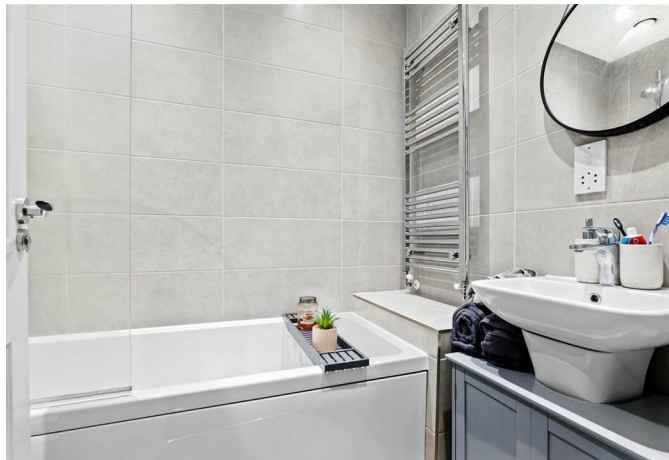
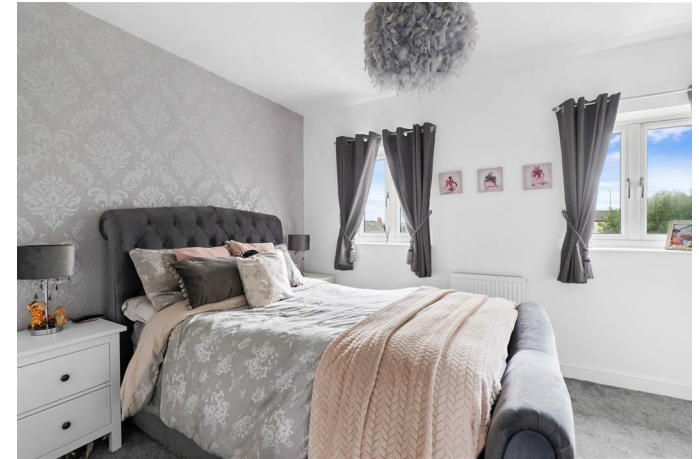

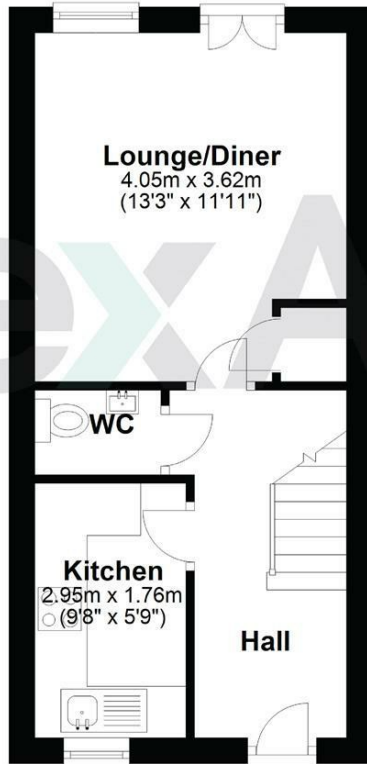
### Council Tax Band B

Approx. 29.6 sq. metres (318.7 sq. feet)

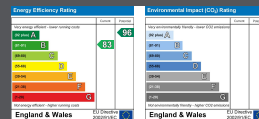
