Double glazed window and door to rear, central heating radiator, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, space and plumbing for washing machine, tiled floor and splash backs

Utility

Double glazed windows to rear, door to side and space and plumbing for washing machine

Conservatory

Double glazed windows and doors and central heating radiator

Bedroom One

Double glazed window to rear, built in wardrobe and central heating radiator

Bedroom Two

Double glazed window to front, central heating radiator and built in wardrobe

Bathroom

Shower, wash hand basin with mixer tap, double glazed window to side, central heating radiator, low level w.c, tiled floor and splash backs and extractor fan

Garage

Double glazed window to rear, doors to front and side

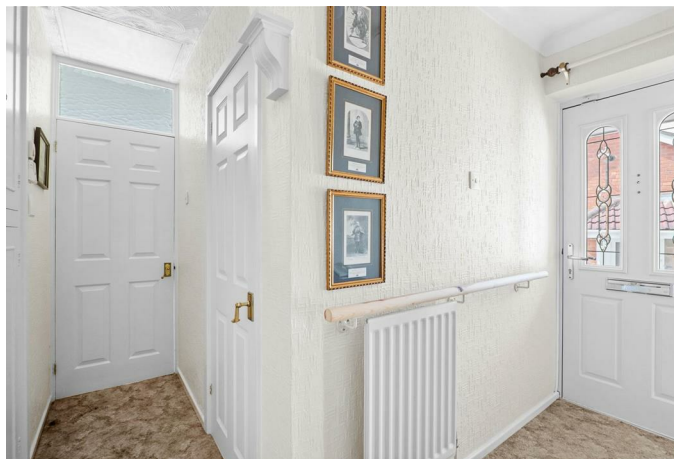

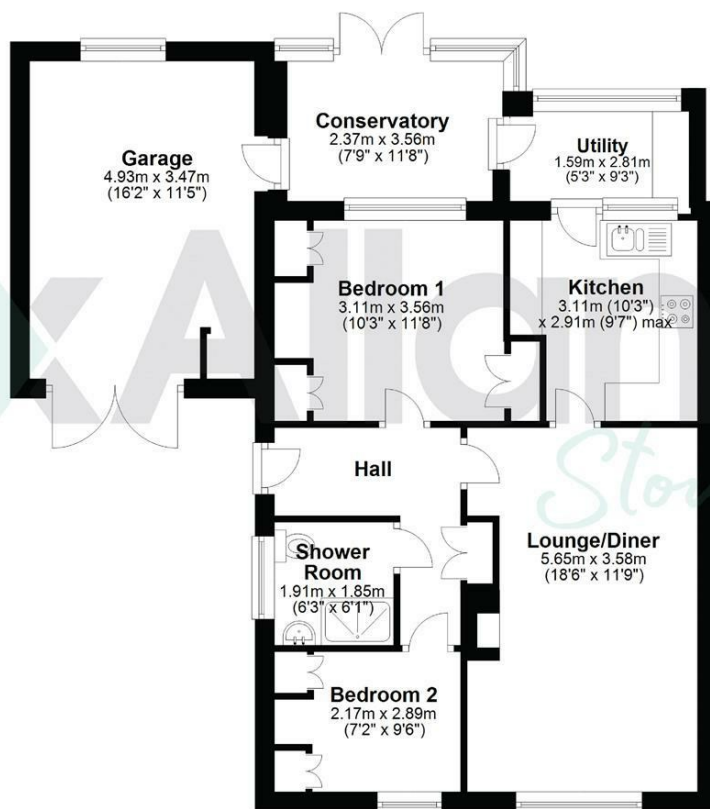
