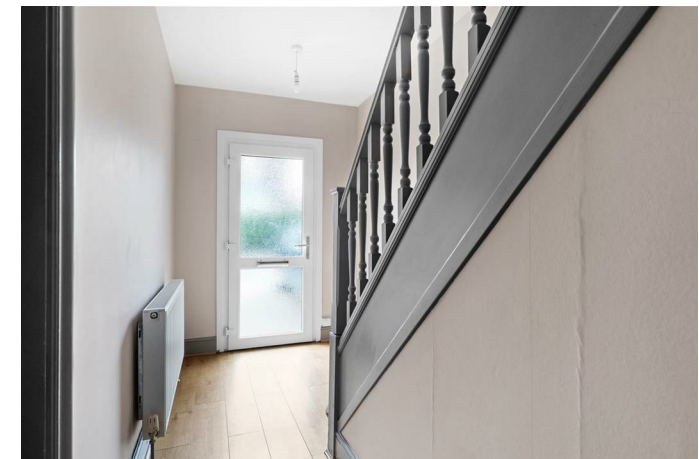

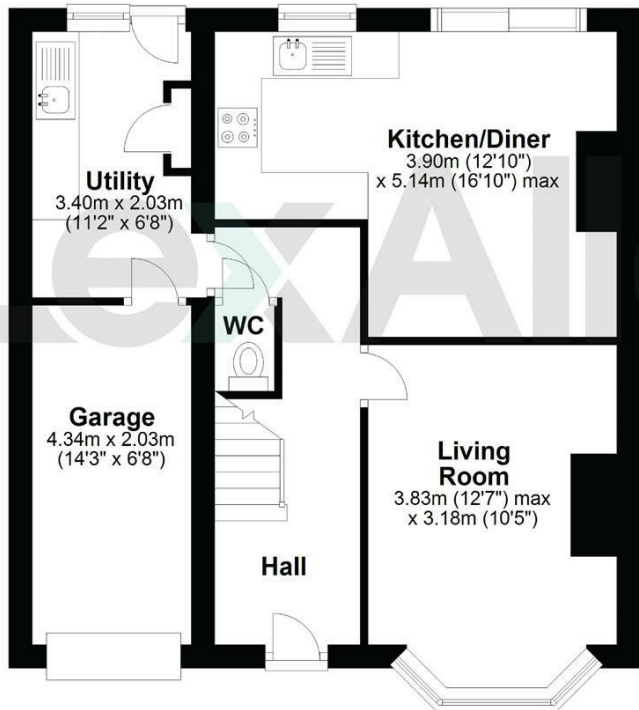

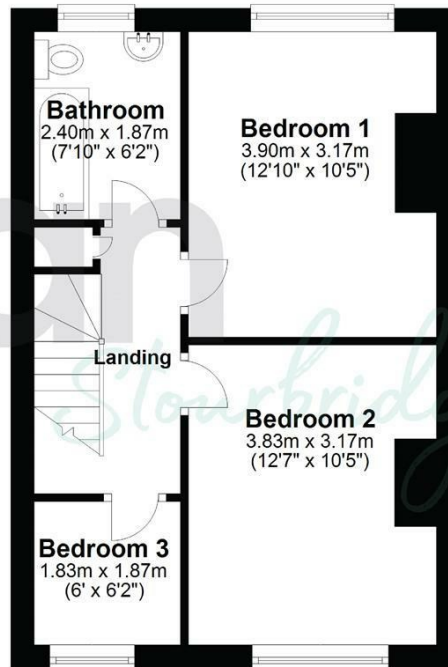
Ground Floor

Approx. 58.2 sq. metres (626.5 sq. feet)



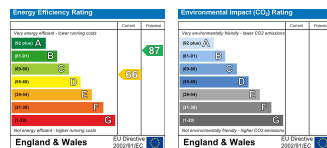
First Floor
