The Location

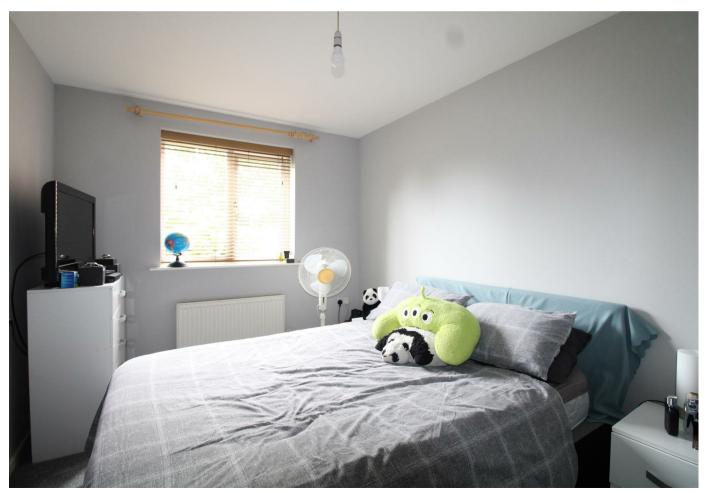

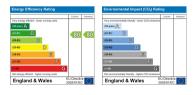
