Double glazed window and door to rear, central heating radiator and cupboard off

#### Kitchen

5' 6" x 9' 2" (1.7 x 2.8)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, tiled splash backs, space and plumbing for washing machine, central heating radiator and combi boiler

#### Landing

Access to loft space and doors off

#### Bedroom

14' 1" x 8' 2" min 12' 5" max (4.3 x 2.5 min 3.8 max)

Double glazed window to rear and central heating radiator

#### Bathroom

Bath with mixer tap and electric shower over, wash hand basin, central heating radiator, cupboard off, double glazed window to front and tiled splash backs

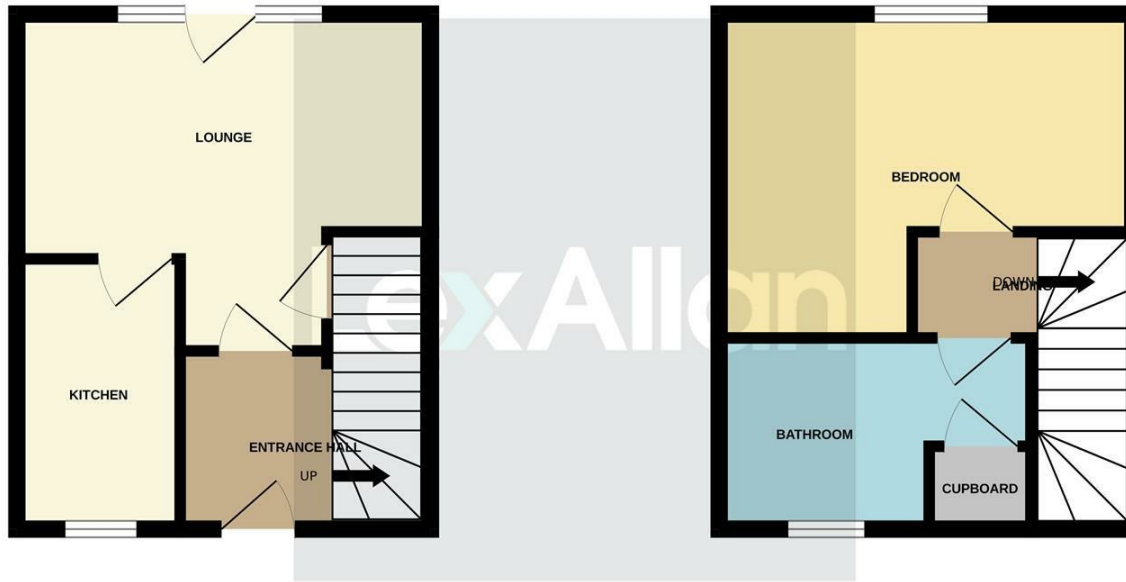
