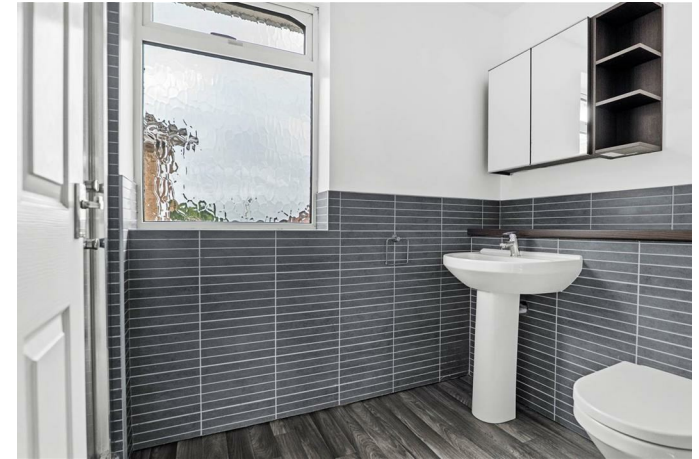

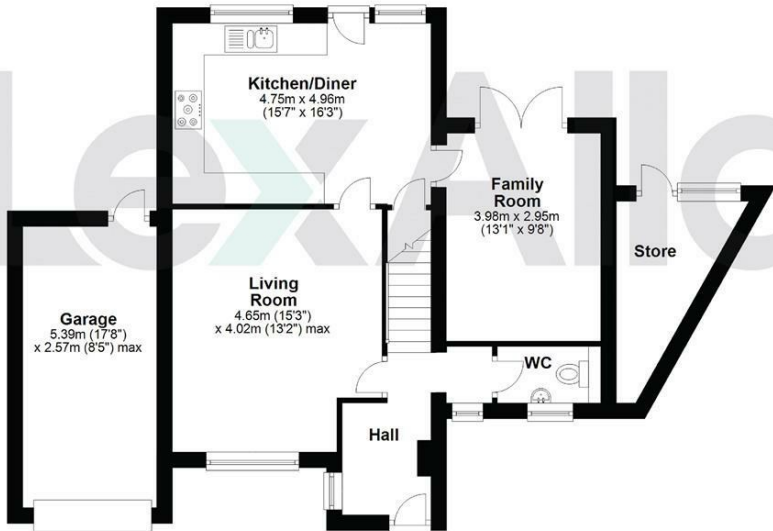

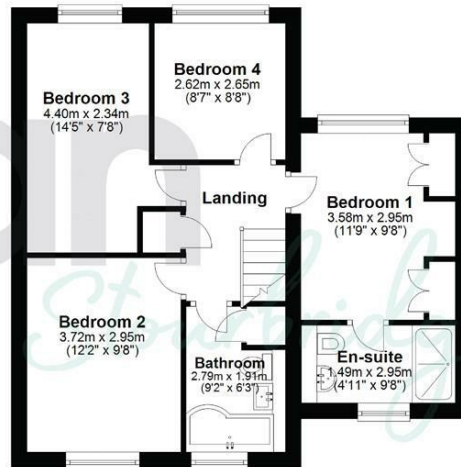
Ground Floor
